# **Funding our Arts Centre**


ow will we get the money' was our workshop in May. Facilitator Steve Payne said everyone had 'a real sense of determination and commitment'.

# **Jock decides** 'It's time...'

ur School of Arts President for 19 years, Jock Munro, resigned as president in May. He said it was time to step down and to encourage someone else to lead the organisation through this next vital and exciting stage.

VP Gene Turvey is acting chair and the committee is considering Jock's replacement on the committee.

Long serving members recently paid tribute to Jock's leadership over lunch. They recounted how Jock joined a new committee in late 1995 when the community first took action to fix the School of Arts Hall (the Kinema). This followed Eurobodalla Shire Council's forced closure of the hall because of structural concerns.

That visit discussed certain design details of Narooma Arts Centre as well as some slight modifications to the southern end of the Hall to facilitate live performances, including gutting the downstairs toilet areas and dressing rooms and renovating them. Check website for details of the Arts Centre.

What to use to clad the new Arts Centre has been an ongoing issue which we think we have finally resolved. It has to be tough to be able to stand up to the coastal environment, require minimal to no maintenance, be long lasting, and also enhance what will be a signature building in Narooma.

After some discussion, Richmond suggested zinc paneling, with recycled timber panels in the front and rear sections. We have since examined images of buildings that have used zinc paneling. The committee thinks it will soften the exterior and appeal to the wider community.

It comes in several colours and takes on a lovely patina as it ages; 'organic' as some put it. While more expensive initially, it is lightweight and so should save on construction costs.

#### Government keeps us guessing

he NSW Government's proposal to repeal the Trustees of School of Arts Enabling Act 1902, the very act under which we operate, has caused us some anxiety. That, plus other moves, seemed like the Government wanted to take back our land after 119 years.

These were part of a review of Crown Lands legislation which included a recommendation to repeal some 'minor' legislation.

With assistance from two of our members (retired solicitors) and our solicitor, we sent in a submission supporting the Act's retention.

Laurelle Pacey also attended a seminar in Sydney which we hope gave us greater clarity. We think our original fears were unfounded. We now await the report on submissions.
